Description: PHYS 317 *Mathematical Physics & Engineering*. 3 semester hours

This course will concentrate on the application of mathematical concepts and methods.

Prepare students with necessary math skills to be successful in junior- and senior-level physics courses.

Topics include applications of ordinary differential equations, vector calculus, and Fourier series to problems in classical mechanics, electricity and magnetism, and wave motion. Matrix methods are applied to eigenvalue problems in rigid body mechanics and vibrating systems with many degrees of freedom.

Student Learning Outcomes:

Objective 1: Students will demonstrate that they understand the concept and have learned the basic skills in using power series and complex numbers in solving physics problems

Objective 2: Students will demonstrate that they understand the concept and have learned the basic skills in using linear algebra and vector calculus in solving physics problems

Objective 3: Students will demonstrate that they understand the concept and have learned the basic skills in solving differential equations and using functions of complex variables in solving physics problems

Homework (40%)

Homework will be assigned regularly on D2L. The homework counts 40% towards the final grade. Each homework should be submitted on D2L as a single PDF file.

NO late homeworks will be accepted unless otherwise pre-approved by the instructor in writing for requests made before the deadline with sound justified/university excuses/business. All homeworks should be hand-written, showing ALL steps.

Exams (60%): Exact time and contents will be announced at least 1 week in advance

Each exam covers about 2 chapters. The three exams will be given equal weight.
