### **COURSE REQUIREMENTS**

Assignments are designed to help graduate social work students explore how AI can support ethical, strategic leadership in social service agencies. Students will analyze real-world challenges, simulate AI-supported decision-making, and reflect on their growth as leaders.

**Subject:** Supporting Our Team Through Burnout and Renewal

Over the past few months, many of you have shared feelings of exhaustion and emotional strain. Your well-being matters deeply.

We are launching a trauma-informed support initiative including:

- Weekly peer support circles
- Optional wellness check-ins
- Flexible scheduling pilot

This reflects our values of dignity, equity, and compassion. Thank you for your continued dedication.

**Ethical Reflection**

- Explore how use of AI aligns (or does not align) with Social Work Values
- Write a 2-page reflection addressing risks, safeguards, and ethical considerations

**Leadership Growth Plan**

- Create a one-page roadmap of goals and strategies for your personal development plan for building tech-integrated leadership skills

**AI Enhanced Strategic Grant Proposal**

- Develop the needs statement, goals/objectives, implementation plan, budget narrative, evaluation plan, and sustainability plan for an organizational/community intervention.
- The proposal must address an identified **organizational or community need**. Each section should build upon the previous section and demonstrate how the proposed intervention will address the identified need.

### 1. Needs Statement (3-4 paragraphs)

A needs statement in a grant proposal clearly identifies a significant problem or gap in a community, explaining who is affected, why it's a problem, and how your proposed project will address it. It serves as the foundation of the proposal, convincing funders of a real, urgent need by providing compelling evidence and demonstrating a clear connection between the problem and the funder's mission.

Include:

- The specific need or problem.
- The population or community affected.
- Use an AI tool (Copilot; Elicit; ChatGPT) to revise for clarity, tone, and funder alignment.
- Evidence or data demonstrating the need; 5 peer-reviewed published studies that will provide “evidence to support your proposed project.
- A brief explanation of how the proposed project will address the need.

### 2. Goals and Objectives (1-2 paragraphs)

Develop the overall goal and measurable objectives for the proposed project.

Include:

- At least **one clear project goal**.
- **SMART objectives** that are Specific, Measurable, Achievable, Relevant, and Time-bound.
- Objectives that directly connect to the identified need.

### 3. Implementation Plan (3-4 paragraphs)

Explain how the proposed project will be carried out.

Include:

- Major project activities.
- Who will be responsible for each activity?

- A timeline for implementation.
- Resources needed to complete the activities.
- How the activities support the project's goals and objectives.

#### **4. Budget Narrative (2-3 paragraphs)**

Explain how grant funds will be used to support the proposed project.

Include:

- Major project expenses.
- A brief justification for each expense.
- How each expense supports the project's activities and objectives.
- Costs that are reasonable and appropriate for the proposed intervention.

#### **5. Evaluation Plan (3-4 paragraphs)**

Explain how you will determine whether the project is successful.

Include:

- What outcomes will be measured.
- How data will be collected.
- When evaluation will occur.
- How results will be analyzed.
- How findings will be used to determine whether the project's goals and objectives were achieved.

#### **6. Sustainability Plan (2-3 paragraphs)**

Explain how the project can continue after the grant funding ends.

Include:

- Strategies for maintaining the project.
- Potential future funding or resources.
- Organizational and/or community partnerships that could support continuation.
- How successful project activities may be incorporated into ongoing services.

\*\*\*The Strategic Grant Proposal will be **developed in sections throughout the semester**. Each section will build upon the previous section and become part of the final proposal.



Students will receive opportunities to develop and refine each component before submitting the completed project.

***At the end of the semester, combine, revise, and submit all sections as ONE complete Strategic Grant Proposal.***
