Course Description

Study of emerging technologies and the management, ethical, and societal challenges they pose to engineering and technology organizations. Emphasis on how managers assess emerging technologies, share organizational strategies, make investment decisions, and create organizational structures that can effectively compete in the global market.

Extensive research and writing assignments are required. Prerequisites: TMGT 595 (or co-requisite) or permission of Department Head.
