Course Description

Examines the development, implementation, and enforcement of policies by institutions of higher education, state higher education agencies, governing boards, and the government. Emphasis is placed on the impacts of policies on institutions and students.

Student Learning Outcomes

- Students will develop an understanding of how higher education policy is made in contemporary federal, state, and other settings, including landmark legislation, and the distinct roles and responsibilities of federal and state government and various other stakeholders.
- Explain theoretical foundations of policies and processes.
- Articulate how public policy issues and problems are defined, framed, and prioritized.
- Analyze public problems and evaluate policy alternatives against criteria such as equity, efficiency, and effectiveness.
- Communicate effectively about the policy process and related theories.
