Course Description:

Through an exploration of philosophical underpinnings, data gathering tactics, and sophisticated analytic tools, this course expands students' understanding of qualitative research. The intricacies of fieldwork, moral quandaries, positionality, power, and critical approaches will all be discussed with the students. A thorough qualitative research proposal or a sophisticated analytical chapter is produced at the end of the course.

Prerequisites: Completion of HIED 695.

By the end of the course, students will be able to:

1. Critically evaluate the theoretical and epistemological assumptions of qualitative traditions.
2. Develop research questions informed by appropriate qualitative frameworks.
3. Employ advanced data collection techniques (e.g., ethnography, narrative, discourse analysis).
4. Analyze qualitative data using coding, memoing, and theory-driven interpretation.
5. Reflect on ethical issues, reflexivity, and positionality in research.
6. Construct an advanced research proposal or analytic manuscript.
