COURSE INFORMATION

Course Description

ART 316: Advanced Drawing

Hours: 3

Advanced Drawing Emphasis on experimental and individually based, expressive statements using drawing media. A variety of subjects, including the figure, will be used. Repeatable to 6 semester hours.

Prerequisites: **ART 1316, ART 1317**, or permission of the instructor.

Advanced Drawing & Drawing as an Expanded Field

Drawing is an expansive and evolving field. Drawing is mark-making: it can exist across materials, processes, dimensions, space, and time. The materials, tools, technologies, surfaces, spaces, and methods used to create and form marks are infinite. In this course, we will consider drawing as a 2D, 3D,

and 4D practice and explore drawing as image, object, construction, action, process, document, installation, site, event, and experience. Mark-making can happen through line, gesture, trace, accumulation, erasure, transfer, layering, repetition, interruption, displacement, transformation, recording, and countless other processes.

Throughout the course, students will investigate drawing through a wide range of conceptual and formal approaches. Students will consider the conceptual and material implications of how and why a work is made. The course asks students to explore what a drawing can be and what drawing can become through contemporary and art historical approaches to mark-making and meaning-making.

Student Learning Outcomes

1. Understand the history, conventions, and current issues related to drawing and contemporary drawing practices.
2. Understand drawing as an expanded field and as a **2D, 3D, and 4D practice** that can exist across materials, processes, dimensions, space, and time.
3. Develop and apply **technical skills in a range of drawing materials, tools, processes, and methods**, including appropriate preparation, handling, construction, documentation, presentation, and care of materials and artworks.
4. Explore **mark-making** through a range of materials, processes, and methods to develop visual language, form, space, materiality, and meaning.
5. Use, understand, and apply the elements and principles of design within artworks, art writing, and critiques.
6. Develop ideas and artworks through **research, exploration, experimentation, translation, transformation, and revision**, including observational, conceptual, imaginative, abstract, non-objective, and interdisciplinary approaches.
7. Consider the **conceptual and material implications of how and why a work is made**, including the relationships between media, materials, processes, scale, dimensions, site, installation, presentation, and meaning.
8. Create completed drawings and expanded drawing projects that demonstrate an understanding of materials, process, technical and conceptual skills, experimentation, and individual direction.
9. Evaluate and analyze own works and the works of others through **critique, reflection, research, and visual analysis**, using appropriate art vocabulary and terminology.
10. Develop a sustained studio practice that demonstrates **experimentation, risk-taking, problem-solving, research, revision, professionalism, and the continued development of a personal visual language and approach to drawing**.

PROCESS & STUDIO TIME

- Every step in the life of each assignment is important and valuable. Discussion with the instructor, classmates, and other sources is expected throughout the production process.
- Some projects will not be completed during class hours. Students are expected to make full use of class time for active studio work and to work outside of class on drawings, sketchbooks, research, and preliminary work.
- On average, a minimum of **six hours per week** (one hour of outside work per every one hour of class time) will be necessary to successfully complete the course.
- Participation, engagement, and discussion with the instructor and peers are important and expected when reviewing artwork, techniques, processes, research, and progress.
- This course will focus primarily on the production and critique of a series of drawings, studies, and expanded drawing projects. Projects may vary significantly in subject matter, scale, materials, processes, and time required.
- Project requirements, format, materials, and estimated time span will be given at the outset of each new project.
- Students are encouraged to use the drawing studio outside of class time, with respect for other classes, students, and professors' schedules.

SUPPLIES, MATERIALS AND TEXTBOOKS

Students are responsible for bringing all of the necessary materials to be prepared for work in class on scheduled days. **Attending class without the necessary supplies or prepared surfaces will be an unexcused absence.*

Textbooks, Readings & Viewings

There are no required textbooks for this course. All required readings/viewings will be shared via D2L/myLeo. Online readings and viewings for the course include selections from content on Art21, MoMA, ArtForum, etc.

Required Materials & Supplies

Please see attached list of required supplies for the course. Additional supplies will be required as needed to complete assignments based on your own project goals, ideas and methods.

COURSE CONTENT & PROFESSIONALISM

Please note that this is a studio art course where professional, global, and varying perspectives on art and humanity are reviewed, discussed, examined, and shared in a respectful environment. Course content and artwork may be challenging, unfamiliar, or outside of your personal experiences and perspectives. Students are expected to engage professionally, thoughtfully, and respectfully with a wide range of ideas, approaches, materials, and viewpoints.

COURSE REQUIREMENTS

Drawing Projects:

Students will complete a series of major drawing projects exploring drawing as an expanded field through a range of conceptual, formal, material, and process-based approaches. Projects may include 2D, 3D, 4D, site-specific, installation, experimental, observational, abstract, and non-objective drawing practices. Any material, tool, process, or method of mark-making may be used when appropriate to the project and concept.

Sketchbooks & Preliminary Work:

Sketchbooks include notes, drawings, thumbnail sketches, studies, brainstorming, research, experimentation, reference materials, and other preliminary work related to the development of assignments. Every step in the process is important and valuable, and students are expected to document and develop their ideas throughout the semester.

Artist & Exhibition Research:

Artist research is required throughout the semester and will be incorporated into major projects and preliminary work. Students will also attend and document **at least two exhibitions** during the semester and consider the relationship between their own work, contemporary drawing practices, and the broader field of art.

Midsemester & Final Portfolios:

Students will submit a **Midsemester Portfolio** and **Final Portfolio** documenting their work from the course. Portfolios will include professionally photographed or documented completed drawings, along with selected preliminary work, research, and process materials. The Final Portfolio should demonstrate the development of the student's work and ideas throughout the semester.

Critiques & Participation:

Students are expected to actively participate in individual and group critiques. Critiques are an important part of the drawing process and provide opportunities to discuss work, process, research, conceptual development, materials, and presentation using appropriate art vocabulary and terminology.

Professionalism & Studio Practice:

Students are expected to come prepared to work in class with required materials, research, preliminary work, and supplies. Professionalism includes preparation, active studio participation, time management, care of materials and studio spaces, craftsmanship, presentation, constructive critique, and professional communication.

GRADING

You will receive a final letter grade for this course. Grades are based on assignments, portfolios, critiques, research, preliminary work, participation, attendance, effort, technical and conceptual

development, experimentation, and improvement throughout the course. Keeping a sketchbook and practicing drawing and mark-making outside of class will be beneficial to your development.

All major projects must be presented for critique regardless of level of finish and submitted to the designated D2L assignment. **Projects that are not presented for the scheduled critique will receive a 50% grade deduction.** Critique and process are an important part of each project, and work will be evaluated based on the development of ideas, consistency of effort, quality and quantity of work, technical and conceptual development, experimentation, and engagement with the course.

Students are encouraged to take artistic risks, experiment with materials and processes, and explore new approaches to drawing.

GRADING SCALE

A—Excellent Work: All requirements have been met and many have been exceeded. Work demonstrates strong technical and conceptual development, thoughtful use of materials and processes, experimentation, and continued growth. Critical and conceptual understanding is demonstrated through studio participation, research, and critique.

B—Very Good Work: Course requirements have been met. Work demonstrates competence in technical skills, materials, processes, craftsmanship, and conceptual development, with thoughtful engagement in the course.

C—Average Work: Course requirements have been adequately fulfilled. Work demonstrates satisfactory technical and conceptual development and participation in critiques, midterms, and finals.

D—Poor Work: Course requirements have not been adequately fulfilled.

F—Failure: Course requirements have not been fulfilled and/or there has been insufficient participation, preparation, or completion of assigned work.

Critiques

In addition to making artwork, students will develop a critical voice in relation to their own work and the work of others. Critiques are an important part of the studio process and will provide opportunities to discuss ideas, materials, processes, conceptual development, and presentation.

Attendance and participation during critiques is required. Even if a work is unfinished, it must be presented during the scheduled critique. Work or students not present for a scheduled critique will receive the **50% grade deduction outlined in the grading policy**. Critiques may not be made up.

Critiques will be conducted in a professional and respectful manner. Students are expected to participate thoughtfully, discuss their own work, engage with the work of others, and use appropriate art vocabulary and terminology.

Late Work / Make-up Policy

Critiques are an essential part of the course. **Even if a work is unfinished, it must be presented during the scheduled critique.** If the work or student is not present for a scheduled critique, the maximum grade the student may receive for that project is **50%**.

Late work for major assignments may be submitted **within one week of the original due date** with a **10% deduction from the assignment grade per day late**, unless the student provides documentation of an acceptable mitigating circumstance. Please see the ETAMU and Department of Art attendance policies for information regarding excused absences.

Late work for non-major assignments, including studio work, plans, research, exhibition research, sketches, and other preliminary work, is generally not accepted. Because these assignments support the development of major projects, students are expected to complete them before moving on to the next stage of the project. Please reach out to the instructor as soon as possible if unexpected or extenuating circumstances arise during the course.

Optional Extra Credit

Extra credit opportunities may be offered to the entire class during the semester. These opportunities are optional and will not negatively affect a student's grade if they choose not to participate. The instructor will provide the same opportunities to all students, and extra credit is offered at the discretion of the instructor. Extra credit is not available for individual assignments or on an individual basis. Students who have engaged in academic dishonesty are not eligible for extra credit.

A total of **5 points of extra credit** may be earned toward the student's final course average.

Grade & Course Questions

Please stay in contact and keep up with the course in D2L. Please ask questions well before an assignment deadline whenever possible. If you have a question or concern about a grade, please contact the instructor to schedule an individual meeting within one week of receiving the grade. Grades cannot be discussed via email. Grades cannot be adjusted based on personal need or desire, and all grades are assigned according to the criteria and policies outlined in the syllabus.

Class Participation & Attendance

Regular and punctual attendance is expected and required. Art is a practice-based discipline, and the learning process requires active and dedicated participation. Attendance is taken during each class session at the beginning of class and/or after break. Students are expected to be present for each class and for the entire class period.

Students will receive a letter grade deduction for their fourth absence, and each additional absence. Being tardy for class equals $\frac{1}{2}$ of an absence. If a student arrives after roll has been taken but within the first 30 minutes, they will be counted tardy. If a student arrives after the first 30 minutes of class, they will be counted absent. Two late arrivals equal one absence.

Most lectures, demonstrations, and assignments will occur at the beginning of class and will not be repeated for students who arrive late or have an unexcused absence. If you are late to class, you will need to notify me by the end of the class period to replace an absence with a tardy. In-class assignments missed may only be made up with official documentation of an excused absence under ETAMU policy. Due to the nature of critiques, they may not be made up.

When a class is missed, it is the student's responsibility to find out what was missed and what is expected from classmates and D2L.

Administrative Drop Policy for Attendance

If a student has been absent for 40% or more of the course at the midterm/midpoint of the semester, they may receive an administrative drop from the course and will need to retake the class when they are better able to attend and successfully complete the course.

Studio Expectations, Safety & Policies

Students are expected to maintain a clean, organized, safe, and respectful studio environment. Follow all safety instructions for materials, tools, equipment, and processes, and ask the instructor before using unfamiliar equipment or hazardous materials.

Please do not dispose of paints, solvents, chemicals, adhesives, or other hazardous materials in sinks or regular trash. Use designated disposal containers and clean your workspace at the end of each class.

Wear appropriate clothing and protective equipment when necessary. No smoking, vaping, or eating is permitted in the studios. Drinks should be kept in closed, spill-proof containers and away from artwork and equipment.

Cell phones, headphones, and other personal devices should not interfere with class activities, demonstrations, discussions, critiques, or studio work. **Headphones may be used during independent studio work**, but should be removed during lectures, critiques, demonstrations, introductions, and class discussions.

Students are expected to contribute to a safe and productive studio environment and to care for shared spaces, equipment, and materials.

End-of-Semester Studio Clean-up

Students are required to attend and participate in the end-of semester studio clean up on the scheduled class date during class hours. Failure to attend and participate in final clean-up will result in a one-letter-grade drop in your final grade. In addition to contributing the clean-up and maintenance of the shared studio spaces, you are responsible for cleaning your work area, storage area, any checked out materials, and hazardous materials area. You are to remove all stored work and materials from both storage and your lockers before the end of the semester.

Final Day to Remove Work and Materials

The final day to remove any work or materials is the last day of Final Exams. Any artwork or materials left after this day cannot be stored for you and will be disposed of the following day.

Studio Storage & Lockers

It is suggested that students use a locker in the studios to store supplies. You will need to bring a combination lock and share the code with your instructor. The shelving provided in the canvas storage room may be used to store paintings and artworks currently being worked on, but students should be aware of the potential for damage, vandalism, and theft when storing work in public areas. Please do not leave materials out in the studios, and be aware of the potential for damage, theft, etc. Paintings may not be left on easels or hanging to dry, and should be stored on the shelves. Please take work home when completed as storage is limited.

AI Course Policy

Generative AI & Student Responsibility to Document Authorship

Generative AI is not permitted in this course for writing, artwork, or other course assignments unless specifically allowed in an individual assignment. When permitted, AI may be used only in the manner and for the purpose outlined in that assignment and may not replace the student's original creative, conceptual, or technical work. Undocumented use of generative AI as original student work constitutes plagiarism and academic dishonesty.

All submitted work must be the student's own original work. Students are responsible for documenting their creative process and maintaining evidence of authorship throughout the semester. This is particularly important for digital, hybrid, experimental, and process-based work.

Students are expected to document the process and development of their work, particularly when working digitally or through processes that may be difficult to document after

completion. Documentation may include sketches, studies, photographs, process documentation, digital files, layers, screen recordings, time-lapse recordings, or other evidence of development. Process documentation may be requested by the instructor at any point during the course.

Writing & Editing Tools

Students may use **Grammarly or similar AI-assisted software for final proofreading, revision, and editing only**. These tools may not generate or substantially rewrite student writing. Use of these tools should be documented and noted with the corresponding submission when applicable.
