Course Description

This course will introduce the students to enterprise organization and architecture. The students will learn its definition, importance, organizational designs, various job skillsets, and team dynamics. We will look at how software development projects stay agile and resilient with the ever-changing business needs and within the architecture of large enterprise businesses. Working with changing systems architecture, risk management, change management, business continuity, operations, disaster recovery, and DevSecOps will also be discussed. We will also discuss methods and strategies of obtaining job experience and staying resilient and relevant for working in computer science in large enterprise environments.
