Course Description

Pharmacotherapy. This course provides an examination of psychoactive medications and their use in the treatment of mental and behavioral disorders. The efficacy and

safety of medications will be discussed. The course presents basic principles of pharmaco-therapy that are the rationales behind the pharmacological treatment of psychological disorders. Applied components will relate to the aspects of the course material to mental health service delivery. The class also examines the historical psychopharmacological perspective, basic pharmacology underlying the use of medication, and recent research in the field. Prerequisite: Admission to a Psychology Graduate program.

Student Learning Outcomes:

1. Identify examples of psychotropic medications that are used in the clinical treatment of commonly diagnosed psychological conditions of clients and describe impact on symptoms
2. Understand the basic structure and function of the nervous system as it pertains to psychotropic medications
3. Understand the ethical parameters of what non-medical mental health professionals can and cannot discuss with clients and advocate.
4. Understand hypothesized therapeutic and side effects of psychotropic medications.
5. Understand the role of counselors in working with psychiatric consultation to help manage symptoms.
6. Understand the role of counselors in talking with clients who have questions about psychotropic medications.
7. Be able to articulate the current about the appropriateness of psychotropic medications for children
8. Be able to articulate the relationship between the pharmaceutical companies, the FDA, managed care, and the consumer.
9. Be able to articulate the counselor's role as advocate and its relation to social justice issues about who gets medicated and who has access to the more expensive medications.
10. Describe the means by which drugs are taken into and distributed throughout the body, how they are metabolized, and eliminated
11. Be able to articulate basic findings of ethnopharmacotherapy and pharmacoeconomics
12. Understand the concepts of tolerance and dependence.
13. Identify principle classes of psychoactive drugs and the typical sites and mechanisms of action
14. Increase awareness of drug interactions and the possible impact of recreational drugs on client functioning
15. Gain knowledge in Services to Promote Safe and Supportive Schools: Understand principles and research related to social-emotional well-being, resilience and risk factors in learning, mental and behavioral health, services in schools and communities to support multitiered prevention and health promotion, and evidence-based strategies for creating safe and supportive schools.

Your grade will be based on the following: (this could change. Please make sure to have the most current syllabus from the course page)

Quizzes 1–5 = 100 points each

There are five (5) quizzes. Each quiz consists of 25 questions, worth 4 points each (100 points per quiz). The quizzes will have true/false and multiple-choice questions. You will have 45 minutes to complete each quiz.

Discussion Post = 24 points each

There will be 5 discussion posts, worth 24 points each. Discussion posts will be submitted under “Discussions” in D2L. This means you will be able to read and comment on other students’ essays. You are required to comment on at least two peer responses.

Posts must demonstrate that the student has reviewed, understood, and contemplated the material from the chapter and other assigned readings. You may include information from other chapters and outside knowledge, but it must be cited appropriately. If the discussion post contains multiple parts, be sure to address each. **All Discussion posts are due at 11:59 pm CT on the Sunday of the week it is due (see schedule).**

Research Paper = 100 points

You will complete one (1) research paper about a psychiatric drug. Details are at the end of the syllabus.

Presentation = 100 points

- 10–15 minute oral presentation recorded and uploaded.
- Use slides or visual aids to summarize research paper
- Each group student must watch 2 of their classmates’ videos and respond with questions and comments in the section detailed by the instructor. Please watch a different topic from what your paper was on

Assignment Details

Students are required to submit a 4–6-page research paper (not including title and reference pages) about a psychiatric drug (e.g., Adderall, Zoloft, Prozac, Ativan, Wellbutrin, etc.). This paper must be submitted according to APA 7th edition style and formatting and will have a minimum of four (4) references in addition to any textbooks that you use for your paper.
