Course Description

This course involves two primary elements:

1. Attending your weekly timeslots in the lab so that you can run participants through our experiments.
2. Engaging with psychology outside of the experimental sessions via other work we provide (e.g., literature review, directed readings, data coding/analysis, lab meetings).

Student Learning Outcomes (SLOs)

1. You will learn how to digest psychological research articles, including interpretation of graphs.
2. You will learn about topics from cognitive psychology.
