Course Information

Course Description

This course will provide opportunities for students to develop and broaden their familiarity with, and understanding of Rock and Roll and other forms of American popular music. Students will be guided through outside reading assignments, aural/visual experiences, and written assignments to allow for an increased musicological understanding of American popular music, its heritage, and its social and historical context.

Student Learning Outcomes

Graduating students will apply appropriate criteria to interpret, classify and evaluate music of various cultures and time periods, in the appropriate historical and cultural context.

In this course, students will:

- Analyze elements of rock music using appropriate vocabulary.
- Demonstrate a knowledge of the origins of rock and rock subgenres.
- Identify connections between rock music and its social and historical contexts.

Instructional Methods

Students will follow outlined activities for each week that include readings, discussions, quizzes, and assignments.

Assessments

Discussions: There will be 6 discussions requiring students to respond to prompts related to class topics.

Quizzes: Over the course of the semester there will be eight quizzes covering concepts from class materials.

Album Reviews: Students will write an essay reviewing a rock album of their choice.

Virtual Rock Festival: Students will create a virtual rock festival featuring artists and songs they consider to be the most significant in rock history.

Students are expected to gain skills in this area by the observation of teaching techniques in their own private lessons and through the observation of teaching techniques of other students in studio class, guest artist classes on campus, and optional conference attendance or optional observations of master teachers online. Students will need to submit teaching videos and acquire a waiver from the student(s) in their videos.
