Course Description

Three semester hours. A course designed to introduce students to classical mechanics.

An introduction to modern classical mechanics as applied to the particles and solid bodies.

If you do not learn classical mechanics, then you will not understand the major developments of science. We will cover the first 7 or 8 chapters of the book:

1. Newton's Laws of motion - 2 weeks
2. Projectiles and charged particles – 1.5 weeks
3. Momentum and angular momentum – 1.5 weeks
4. Energy – 1 week
5. Oscillations - 2 weeks
6. Calculus of variations – 1 week
7. Lagrange's equations – 2 weeks
8. Two-body central-force problems – 2 weeks

Prerequisites: (Lvl U PHYS 2426 Min Grade C or Lvl U PHYS 212 Min Grade C) and (Lvl U MATH 314 Min Grade C or Lvl U MATH 2415 Min Grade C Concur) or (Lvl U MATH 315 Min Grade C or Lvl U MATH 2320 Min Grade C Concur)

Student Learning Outcomes

- Students will understand the discipline-specific knowledge in classical mechanics, covering the subjects:
 1. Basic concepts of classical mechanics
 2. Newton's laws and applications
 3. Planetary motion
 4. Oscillations
 5. Lagrange's equations
- Students will know the concepts of classical mechanics and demonstrate a proficiency in the fundamental concepts in this area of science.
- Students will be able to solve problems using their knowledge and skills in modern physics. They will use critical thinking skills to formulate and solve quantitative problems in applied physics.

Exams

- There will be **two midterms** and a final. The midterm exams will be weighted equally (**30% each**). The **final** will be cumulative and accounts for **40%**.
