Course Information

Course Description

This junior recital is required of all undergraduate music majors in a BM concentration (performance and music education). The junior recital is a 30-minute recital.

Student Learning Outcomes

1. Graduating students will synthesize content from across the curriculum to demonstrate mastery of musical skill and knowledge in a capstone experience.
2. Demonstrate ability to research in depth a topic related to piano pedagogy.
3. Demonstrate ability to write a quality, academic, research-based paper.
4. Demonstrate ability to synthesize information into an audience friendly 30-minute presentation.
5. Demonstrate ability to create corresponding visual aid to presentation.
6. Demonstrate ability to create corresponding hand-out to presentation.
7. Demonstrate ability to give presentation to an audience of peers and community members.

Course Requirements

Instructional Methods

Students will meet as needed with the instructor throughout the semester. Students will choose a topic, conduct research, write a document, and then convert that document into a presentation with supporting hand-out and visual aide. The presentation is then given in a lecture recital format.
