Course Description

Concepts and principles of breeding, feeding and management of beef cattle in the United States. A survey of the past, present and future ideas of the beef cattle industry.

2. Understand and describe the various types of beef cattle operations and the challenges associated with them.
3. Explain and utilize information to support their goals and management decisions in all sectors of cattle production.
