This course is an introduction to the concepts, principles, problems, and applications of real estate. We will emphasize all functional areas and institutions of real estate principles and practices with real world applications.

This course is a preparatory course for taking the Texas Real Estate License Exam. This course is NOT required to take the license exam and does NOT count as one of the 6 required courses necessary to actually sit for the initial Salesperson Licensing Exam. * See Texas Real Estate Salesperson Prelicensing Education Requirements below.

This course is a fully Online course (01W), all assignments and exams will be online, and no in-class participation is required. Each week will consist of completing the assigned modules and appropriate quizzes and some combination of live instruction or pre-recorded supplemental information. All sessions will be recorded for those who are unable to attend.

Materials Required:

In order to access the course materials for the course, you will need to purchase the Kaplan Texas Salesperson Exam Prep Package. The cost is \$99 and should be purchased online. See instructions below. Due to the short, 8 week, time window for the course, it is advised that you go ahead and purchase the materials online prior to the class start date.

Exams:

This course consists of 2 major parts, The National Real Estate Exam Prep Online Video Course, and the Texas Real Estate Exam Prep Video Course.

There are 12 units in the National section and 6 units in the State section. At the end of each unit, there is a multiple-choice Unit Exam (for a combined 60% of your course grade). You will

need to make a 100 on each unit exam to receive credit for completion of the unit. You can retake the Unit Exam as many times as needed.

After successful completion of all the multiple-choice Unit Exams for the National Real Estate Exam Prep Online Video Course, you will take a National Final Exam and after successful completion of all the multiple-choice Unit Exams for the State Real Estate Exam Prep Online Video Course, you will take a State Final Exam (for combined finals grade of 35% of your course grade). A passing score of 70 is required to receive credit for completion of both Course Final Exams. You are allowed to take the Final Exams multiple times to reach that score.

NOTE: After successful completion of each Unit Exam and Final Exam, you will need to upload a screenshot into the appropriate drop box in D2L showing the score obtained and the name of the student to receive the grade.

Guest Speaker Reviews:

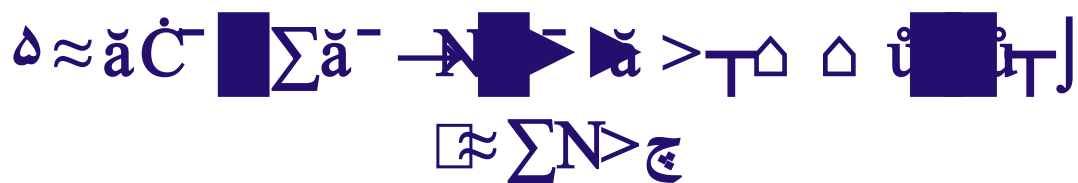
