COURSE INFORMATION

Course Description

COMS 1311: This course addresses theories and related skills for evaluating types of communication, including a survey of computer-mediated communication, nonverbal communication, political communication, gender communication, and small group communication, as well as strategies used in informative, persuasive, and ceremonial communications. Recommended for students pursuing careers in sales, training and development, human resources, teaching, law, the ministry, politics, event planning, corporate training, upper management, management, or other professions requiring communication skills.

Discussion Boards SLO #1,4	100 points	varies	Discussion boards require you to create your post and reply to at least 3 classmates. Each discussion varies according to requirements and the scale of points. Students should read each discussion board assignment to understand the instructions and expectations. You must be respectful during all discussions, even if/when you disagree with a classmate. If any offensive material is posted, I will remove it, and you will receive a 0 for the assignment. Any plagiarism will result in losing all points for that particular discussion. • Each post should be written with a minimum of 150 words. • Each response to your classmates must be at least 75 words. The submission text box must be used to type in your post and reply to classmates. Files are not accepted. Total Points—100 points (5 DB x 20 points each) Note: Students must have an original submission before they reply to others. So, a student cannot receive a grade for a response if they didn't have an original post by the deadline as part of the assignment expectations. If a student chooses to include the guiding questions in their submission, please note the questions are not part of the required word count because they're not original comments.

Speech Outlines SLO #1--4	100 points	varies	The outline functions as the foundation and driver of your speech, guaranteeing its structure, timing, and impact. Following the provided example (found in the assigned unit's module) is obligatory for all students. Students who do not include a references page and/or write their outline as an essay will receive an automatic 0. Total – 100 points (2 outlines x 50 points each) <i>Only PDF or Word file types are accepted. Linked documents are <u>not</u> accepted. Additional instructions and requirements will be provided in the assignment descriptions.</i>
Exams SLO #1-4	200 points	Midterm and final	Exams are used in this course to assess learning and student learning outcomes. There are two major exams, a midterm and final. The midterm covers chapters 1-11. The final covers chapters 12-16.

Course Specific Procedures/Policies

Late Work

You will receive a thorough description of all assignments before they are due. Assignments must be submitted online via the D2L assignment tools. Homework assignments submitted via e-mail, messaging, or hard-copy form will not be accepted.

I expect assignments to be submitted by their due date. However, you can submit your assignment 48 hours after the due date—**without penalty**. Once that 48-hour window passes, assignments will not be accepted.

Extenuating circumstances: I know that it is impossible to consider all the possible circumstances that may prevent you from submitting your assignments on time. I am sensitive to some of those circumstances. Formal documentation will be required if you submit an assignment after the 48-hour grace window. Approval is left to the instructor's discretion and may require further action that's not mentioned. However, having assignments for other classes, a hectic work schedule, tech-related issues, or not feeling it yet are not extenuating circumstances.

NOTE: Missing a significant amount of the course limits the student's ability to meet the course objectives regardless of circumstances. Students who experience significant life events such as death, critical illness, or other related matters that result in excessive inactivity in the course should connect with an advisor to determine appropriate next steps, which may include dropping the course.

Interaction with Instructor Statement

All students will be held to a high level of professionalism. To this end, all discussions and engagement must be professional, civil, and friendly, even when students disagree with each other or with the instructor. There should be no name-calling, profanity, or disrespectful comments.

Any student who does not follow these standards may see a negative impact on their grade and will be referred to student conduct, which may result in being removed from the class.
