There is no required textbook for this course. However, this course does require extensive reading of research articles, and additional book material. All material relating to the student's research focus is relevant.

Course Description/Explanation

This course is the culmination of an Honor Student's honor thesis. The student has likely spent one or two prior semesters gathering research material (reading, writing), formulating a research plan or agenda and initiating the draft of a professional paper. In this process the student has also likely planned how, where, and when the final thesis will be presented and defended.

Student Learning Outcomes/Core Competencies:

1. Illustrate critical thinking skills through written work, and oral presentation
2. Demonstrate the ability to formulate a critical research topic and move it through the stages/steps of research methods culminating in a finished research paper of professional caliber
3. Be able to present the research paper with confidence to a professional audience, with proper delivery and adequate response to critical questions asked about the entire research project
