**Course Description:** This practical, movement-based course provides basic instruction in different dance styles, including include line, folk, square, fitness, and collaborative. You do NOT need to sign up with a colleague or partner! Enjoy this time of putting down your phone, connecting with others, and learning something new while being active.
