SACSCOC requested additional information via email; the response has been incorporated into the original submission.

Texas A&M University-Commerce proposes the implementation of the Region

10 Education Service Center off-campus instructional site (OCIS), effective August 2, 2021. The site is located at 400 E. Spring Valley Road, Richardson, Texas 75081-5101.

The Texas Superintendent's Certification program at the site is anticipated to operate for a minimum of three years with the possibility of extending beyond that timeframe. An initial enrollment of 15-20 students is expected. The program is currently delivered through distance education at the institution, but with the implementation of the proposed site, the program will also be delivered through face-to-face instruction. The target audience will be aspiring superintendent candidates from the Dallas area.

The projected schedule of course offerings and course descriptions were provided and appear to be appropriate. The program coordinator was identified and appears to have appropriate credentials for serving in this role.

A faculty roster was provided detailing the credentials of the faculty members assigned to teach in the program. The faculty members appear to have appropriate credentials for the courses assigned. Keep in mind that the ultimate determination of faculty qualifications is the responsibility of the peer review team who will assess the program as part of the institution's next SACSCOC accreditation review.

The library and learning resources available to support the program were provided and appear to be sufficient. The Research and Learning department of the library includes five librarians and two library associates who provide research assistance to students, faculty, and staff members. The learning resources include print and electronic books and journals. The availability of discipline-specific refereed journals and primary source materials was noted and includes the International Journal of Leadership in Education, the Journal of Educational Administration, and Educational Administration Quarterly. The institution has agreements or memberships with the following agencies to expand resources for the program: the Texas A&M University System Libraries, Greater Western Library Alliance, and TexShare consortia. Students may also access resources through the Interlibrary Loan program. Students enrolled in

the Texas Superintendent's Certification program will access these discipline-specific learning resources onsite or online. They may also have materials delivered to them electronically or by the USPS. Students and faculty members can access information electronically through the library website on a 24/7 basis. Each academic department has a librarian assigned as a liaison to assist faculty members in building collections for their respective disciplines. Resources to support students in accessing and using learning resources include study rooms, networked desktop computers, laptops for student checkout, scanners, and copiers.

The physical facilities and equipment available to support the program were described and appear to be adequate. The Region 10 Education Service Center will provide meeting space and technology for the program; courses will be scheduled in the evenings and on the weekends. Facilities include an office, meeting space equipped with a multimedia system and various technology applications; copiers; printers; fax machines; wireless internet; instructional software; a lounge; and a breakroom. The technology staff onsite will also be available to assist faculty. This proposed off-campus instructional site will have no impact on the current physical facilities or equipment.

The site will be reviewed, and may include a site visit as part of the institution's next fifth-year and/or decennial review.

The Board of Trustees of the Southern Association of Colleges and Schools Commission on Colleges reviewed the materials seeking approval of the Region 10 Education Service Center off-campus instructional site (OCIS). It was the decision of the Board to approve the site and include it in the scope of accreditation. The approval extends only to offering workforce development certificates; if the institution decides to offer other programs at the site, it must follow the procedures for notification and approval as for any other off-campus instructional site.

Enclosed is an invoice for \$500 to help defray the cost of reviewing the prospectus.
