Thank you for your letter of February 18, 2013, providing notification of the closure of three approved international locations.

The sites and information concerning each are as follows:

1. Sarajevo Graduate School of Business  
International Burch University  
Sarajevo, Bosnia

The institution was informed of the decision to close the site on August 13, 2012. Students who had not completed their programs were advised by program directors and provided options including transfer to comparable programs. All students at this site finished their course of study and have received diplomas from Texas A&M University-Commerce. None incurred additional expenses in completing their course of study.

Courses were being taught by faculty members from the institution or full-time faculty members from Texas A&M Commerce. Since faculty members hold full-time positions at their respective institutions, none of the faculty members were adversely affected and continue to hold full-time positions. The program director at the site is being assisted by letters of recommendation as she seeks other employment.

The institution was informed of the decision to close the site on August 13, 2012. Students who had not completed their programs were advised by program directors and provided options including transfer to comparable programs. Four students in Serbia are completing their course of study according to scheduled courses to be completed in June 2013. The plan of study was provided.

Courses were being taught by faculty members from the institution or full-time faculty members from Texas A&M Commerce. Since faculty members hold full-time positions at their respective institutions, none of the faculty members will be adversely affected by the closure and continue to hold full-time

positions. The program director at the site will remain through students' completion of their program. He has not requested assistance in locating other employment.

3. International Institute of Higher Education Morocco

The institution was informed of the decision to close the site on August 13, 2012. Students who had not completed their programs were advised by program directors and provided options including transfer to comparable programs. Fifteen students at this site have not completed their course of study. Twelve students in the M.S. Marketing program have a schedule of courses to be completed in December 2013. The plan was provided. Three students in the M.S. in Finance program have a schedule of courses to be completed in November 2013. The plan was provided.

Courses are being taught by faculty members from the institution or full-time faculty members from Texas A&M Commerce. Since faculty members hold full-time positions at their respective institutions, none of the faculty members will be adversely affected by the closure and continue to hold full-time positions. The program director at the site will remain through students' completion of their program. He has an existing, full-time position with the institution and serves as its provost.
