Course Description: Orchestration is a comprehensive study of standard Western

> instruments and common practices in scoring for them. The course will begin with an examination of specific instrument ranges, transpositions,

acoustic properties, timbral qualities and characteristics when

combined with other instruments. Later material will focus on various

approaches to writing for chamber and large ensembles.

Student Learning Outcomes:

After successful completion of the course, the student will be able to:

- Demonstrate familiarity with the characteristics of all standard Western instruments.
- Identify significant orchestrational approaches and techniques through score study.
- Successfully transcribe vocal or keyboard works for chamber or large ensembles.

Course Requirements: There will be frequent occasional assignments given in this course, each of which intended to reinforce or further a concept covered in class. All homework assignments MUST be completed in pencil or through use of computer-notation software. Assignments completed in pen may not be accepted for credit. Assignments are due in class on the stated day, late assignments will not be accepted for credit.

> There will be two exams this semester and specific information as to content will be provided at least a week before each exam is administered.

There will be three chamber-ensemble projects this semester, one for strings and harp, one for woodwind ensemble, and one for brass

ensemble. In addition to the three chamber projects, there will be a capstone project consisting of an arrangement of a significant solopiano work for symphony orchestra.
