Course Description

Explores rural community health nursing, focusing on historical development, philosophy, health care systems, epidemiology, individuals, families, and specific aggregate groups. Applies

theoretical and empirical knowledge in using the nursing process in rural community settings to promote, maintain and restore health. Focuses on trans-cultural nursing concepts, rural, and home health care delivery. Diverse roles of the community and public health nurse are examined, and a rural community assessment is completed using research and data processing skills.

Student Learning Outcomes (Class)

By the end of the course, the student will be able to:

1. Examine the development and role of public health, rural health, community health and Community-based nursing, and the transformation of the health care system domestically and globally (AACN Essentials: 3.1 (a, c, d, e); 3.3 (b); 3.4 (e); 3.5 (c); BON DECS: IV. A).
2. Discuss ethical theories and principles, laws, and government regulations inherent in the core functions of community-oriented nursing practice (AACN Essentials: 3.1 (c, h, i); 3.5 (c); BON DECS: III. A).
3. Explore the relationships between the epidemiological approach and levels of prevention to understanding and identifying the causes of disease, the environment and human health and disease (AACN Essentials Domains 3.1(b, c, e,); 3.3 (b); BON DEC: IV A, B, G.).
4. Identify the impact of primary health care, health promotion and disease prevention, and community resources on the health needs of individuals, families, aggregates, communities and cities (AACN Essentials Domains 3.1(a, b, c, e); 3.2(a, d, e) ; BON DECS: IV B, C, G).
5. Identify how the role of the nurse working with community organizations (voluntary, governmental, business, labor, and faith-based) collaborate, prepare for, and respond to disasters and bioterrorism (AACN Essentials Domains 3.2 (a, h); 3.6 (a, b, c, d, e) ; BON DECS: IV G).

Student Learning Outcomes (Clinical)

By the end of the course, the student will be able to:

1. Demonstrate clinical judgment and professional behavior incorporating socio-cultural and ethnic values and evidence-based practice in community-oriented care (AACN Essentials Domains 3.1 (c, d, e); 3.3 (a, b, f); 3.5 (a, e); DEC IV).
2. Use the epidemiological method to identify the health status of the population and plan care addressing the appropriate level of prevention (AACN Essentials Domains 3.1(b, c, e,); 3.3 (b); DEC III A).

Use a social science theoretical framework to assess the physical, developmental, environmental, psychosocial, and spiritual influences to identify actual and potential risk factors and resources for families and groups/populations within the community (AACN Essentials Domains 3.1(b, c, d, e) 3.2(c, e, h); DEC IV).
4. Establish effective communication with individuals, families, groups, communities, and other health care professionals to promote optimum well-being (AACN Essentials Domains 3.1 (n); 3.2(b, c); DEC IV A).

- Describe the nurse’s role and participation in community based care, including emergency preparedness and disaster response, with an awareness of environmental factors and the risks they pose self and patients (AACN Essentials Domains 3.2 (a, h); 3.6 (a, b, c, d, e; DEC IV G).

COURSE REQUIREMENTS

Minimal Technical Skills Needed:

Using the learning management system, using Microsoft Word and PowerPoint.

Classroom Instructional Methods

This is a blended course requiring students to complete reading assignments, online activities and independent study to be successful. Course objectives may be met through individual study using suggested resources, active involvement in classroom activities, formal, and informal exchange of ideas with classmates and colleagues regarding specific topics as well as utilizing critical thinking skills. Teaching methods include lecture, seminar, discussion, small group work, independent study of texts and library resources, computer-assisted instruction, audio-visual aids, and assignments. Faculty will provide guidance and consultation as students identify learning needs and demonstrate course objectives.

A minimum grade of 75 is required to pass the course. The average of the exams (RN Community Health content mastery exam, Exams 1, 2 and final) MUST be 75% or greater before ANY other course grades are averaged to compose the final grade. If the exam average is below 75%, the student will receive the grade of “D or F” for the course regardless of any other grade(s).

Other graded assignments will not be added to the final grade unless exam grade average is 75% or higher.

All students with an exam grade of less than 75 should review their exam. It is the student’s responsibility to contact their course faculty or the Student Success Coach to set up an appointment to review the exam. The exam must be reviewed before the next scheduled exam. Only the most current exam may be reviewed. All students are welcome to review their exams by scheduling an appointment with course faculty.

Successful completion of the examinations and other required assignments will enable the student to meet the student learning outcomes.

For Standardized Exams:

TAMUC School of Nursing utilizes Assessment Technologies Institute (ATI) assessment materials (content mastery practice assessments and content mastery proctored assessments) to guide and assess mastery of nursing content necessary for entry into practice. Specific ATI assessment and grading guidelines are outlined in the document entitled “ATI Content Mastery Series (CMS) Assessment Grading Rubric” in the LMS module folder entitled “ATI Assessment Grading Rubric”.

Clinical: To receive a passing grade in the clinical component of this course, students must achieve a 75% average on graded clinical assignments, achieve a passing completion on weekly logs, complete the required number of clinical hours (135), and receive a satisfactory clinical evaluation. Failing more than 1 clinical day may result in clinical and course failure. No call absences will result in failing the clinical day.

Note: Clinical is graded Pass/Fail. If the student fails the clinical component, the entire course must be repeated.

Adherence to clinical expectations is required for successful course completion. Clinical activities are documented on the clinical journal log.

Successful completion of the required assignments listed will enable the student to meet course and clinical student learning outcomes.

Student Responsibilities or Tips for Success in the Course/Clinical:

- Logging into the course website regularly during the week

- Checking emails regularly and before class/clinical
- Updating semester calendar with communicated changes
- At least three hours of weekly study
- Attendance at all class meetings, clinical activities, seminars and simulations

Late Submissions:

It is expected that students will submit all class and clinical assignments on time. If an extension is needed, it should be requested **before** the due date/time and may or may not be approved at the discretion of the course coordinator. Unexcused late assignments will be penalized 10% per day for each of the first two days overdue; on the 3rd day, the grade will be assigned as 0%. Communication on these matters is the student's responsibility. Multiple instances of late clinical assignments may result in receipt of a Student Performance and Behaviors Evaluation Form and, possibly, failure of clinical/course.

Rounding of Final Grades

Faculty may round final grades in alignment with ASTM International Standards which allow for 'rounding only after all calculations leading to the final result are completed.' Therefore, rounding of grades for individual assignments is not accepted practice. Rounding will be calculated using the "five-up" rule allowing for decimal numbers that meet or exceed the halfway point between two values to be rounded up to the larger value. For example, a grade of 89.5 equals in A, whereas a grade of 89.49 equals a B. Prior to awarding of final course grades, faculty will ensure gradebook software in a course is in alignment with this policy. Paper Submissions:

All documents submitted online are to be in .docx (Word) or .rtf (Rich Text File) format. **No other formats will be accepted (JPEG, GIF, PDF, etc.).**

Group Work:

All group members will receive the same grade on any group work. A student can be removed from an assigned group if the other students in the group come to the Course Coordinator and report that a student is not doing a fair share of the work. If this issue occurs, the Coordinator will communicate with the student reported as not contributing and may remove the student from the group. The student will then be responsible for completing the assignment solely. It is expected that the group will make the attempt to resolve the situation within the group before coming to the Course Coordinator for intervention.

Assignments (Class)

The due dates are noted on the Course Calendar. Assessments are to be submitted to D2L. The rubrics for assessments are located within this Course Syllabus.

Movie Assignment:

Students will watch a documentary (available through the library link in D2L) and review the different types of nursing in the community. Students will then answer questions and submit via the course D2L. This assignment addresses Class Outcomes # 1, 2, 4, & 5, and Clinical Student Learning Outcome #5.

Community Assessment Paper and Presentation:

The purpose of this assignment is for students to work as a group to provide a comprehensive report reflecting theoretical study and practical analysis of the health of a designated community population.

Conduct a windshield survey and observe a variety of community members in various locations. Make a video/slide show of the community. Gather data by conducting informant interviews of at least ten (10) key individuals in the community (health care providers, religious leaders, educators/teachers and principals, elected officials such as the mayor and city council members, fire fighters, EMT/Paramedics, police, and business owners) and at least ten (10) local residents who are not considered key individuals. Students do not need to wear the uniform when completing the assessment activities, but the student ID badge should be available, in case of concerns, for these interviews.

Group and city assignments will be discussed the first day of class and posted in the course. Only one group member is to submit the paper. Students should use the Community Assessment Paper Grading Rubric in D2L as a guide for completion of the assignment. This assignment addresses Class and Clinical Student Learning Outcomes #1- 5.

Swift River Assignments:

The purpose of these assignments is for students to work individually to care for simulated patients with specific health conditions discussed in rural and community health class. The three assignments focus on clients receiving care in the community, those suffering from violence and abuse, and those with substance abuse issues. These assessments address Class Student Learning Outcomes #1- 5.

Virtual Case Studies:

The purpose of these assignments is for students to work individually to care complete case studies related to epidemiology (John Snow, Food and Water borne illnesses), environmental (Pesticides) and violence and abuse (Human Trafficking). Completion of the case studies will deepen the students' knowledge related to the assigned topics. These assessments address Class Student Learning Outcomes #1- 5.

Exams:

Three (3) instructor-developed exams are scheduled. The third exam includes comprehensive questions and includes a group component. These exams are taken online in class and are timed. These assessments address Class Student Learning Outcomes #1- 5.

Students are responsible for making appointments with faculty to review exams or to discuss failing grades. The window for instructor-developed exam review is open until the date of the next exam. See the course schedule for the date, time, and content of each exam.

Assignments (Clinical)

Clinical Logs:

The purpose of this assignment is to document weekly clinical hours. The log should include hours spent at assigned facilities, and the hours spent on the group assignments such as researching, group meetings, interviews, etc. Hours reflected on the log need to be signature verified by individuals at the facilities or by those being interviewed, so a copy of the log should be available for all clinical assignments. For each entry, indicate the clinical outcomes(s) you have met with the activity by number and provide a one to two sentence key takeaway from the activity. Each week the student should be adding hours to the previous log and keeping a **cumulative** total of hours. Upload the updated document every two weeks. By the end of this course, the final clinical log will indicate all the experiences and assignments you completed during the semester and should total at least 135 hours (Clinical Student Learning Outcomes #1-5).

Clinical Evaluation

The purpose of this assignment is for students and instructors to assess individual clinical performance over the course of the semester. The overall evaluation of your clinical performance must be satisfactory. (Clinical Student Learning Outcomes #1 - #5)

General Information for Clinical Experiences

The clinical component is PASS/FAIL. Students are required to accumulate a **minimum** of 90 hours of clinical time throughout the semester.

Students must wear a uniform and ID badge and adhere to the dress code of Texas A&M University-Commerce Nursing for experiences at clinics, home health agencies, schools, interviews, and experiences at agencies/facilities unless otherwise instructed by faculty. Students should arrive on time. Faculty will visit students at clinical sites throughout the semester and consult with you and clinical staff regarding activities, appearance, and behaviors.

At all sites, students must adhere to the expected clinical behaviors. See the BSN Student Guide for more information.

Bring your individual skills checklist to every clinical experience. Nurses with whom you work will need it to document your skills in the clinical area.

If the clinical site completes work early, students must contact their clinical instructor and receive a response **before** leaving. The first time you contact any instructor, identify yourself in the text. If you do not receive a response to your text after 20 minutes, text the Course Coordinator.

Students are NOT allowed to ride in the vehicles of any facility staff member nor are they to provide a ride to any facility staff.

Students who must miss clinical for any reason should notify their clinical faculty and assigned clinical site (contact numbers are in the clinical site list) **prior** to the start time of the clinical day. Any missed clinical day/time will have to be made up.

All students are expected to manage their complex schedules and attend clinical activities as scheduled. Students are expected to plan in advance and have the address and information regarding clinical sites ready the day prior to clinical. Come to clinical with the objectives to be met that day in mind.

Syllabus Change Policy:

The syllabus is a guide. Circumstances and events, such as student progress, may make it necessary for the instructor to modify the syllabus during the semester. Any changes made to the syllabus will be announced in advance.

Class Expectations:

Class attendance is mandatory. Notify faculty in advance of any absence. As an adult learner and responsible professional, the student is responsible for reading and completing assignments prior to class and for being prepared to participate in discussions over the assigned material. Content will be covered in class, through ATI Engage activities, and through other assigned materials.
