



BACHELOR OF APPLIED ARTS & SCIENCES IN ORGANIZATIONAL LEADERSHIP

The BAAS in Organizational Leadership is a competency-based program that prepares innovative leaders for employment in an increasingly technological and global society. This entire program is available online and is tailored specifically for non-traditional adult learners. Try to complete their degrees, or are in the workforce in need of a degree. The degree program focuses on leadership skills, including instruction in organizational planning, dynamics of leadership, finance, team building, conflict resolution and mediation, communication, and other managerial skills that are applicable to all types of organizations including business, government, non-profits, and education.

The BAAS in Organizational Leadership is an affordable way to earn a baccalaureate degree with a total of 120 semester credit hours. The competencies and courses are offered in seven-week terms so students will be able to accelerate their time to degree completion. Students will pay a flat rate tuition fee per term; regardless of how many competency modules they take during the term.

TEXAS A&M UNIVERSITY-COMMERCE ADMISSION REQUIREMENTS

Texas A&M University-Commerce provides educational opportunities for both traditional and nontraditional students. Admission to Texas A&M University-Commerce is the same for all students.

Applicants are guaranteed admission to TAMU-C if they meet one of the following requirements:

- Rank in the top 30 percent of your graduating class
- Have a composite ACT score (composite) of 21 or better
- Minimum combined SAT (prior to March 2016) of 980, or Minimum combined SAT (after March 2016) of 1060

Applicants whose date of graduation from high school is five years or more prior to the date of application, or who have completed General Education Development (GED) certification, are exempt from providing SAT/ACT entrance scores, but must take the Reading Comprehension Test (RCT).

Texas Senate Bill 1321 entitles residents of this state to seek admission to public institutions of higher education without consideration of courses undertaken ten or more years prior to enrollment. This bill has been called the "Right to Academic Fresh Start" and it gives students the option of electing to have coursework taken ten or more years prior to the starting date of the semester in which the applicant seeks to enroll either counted as usual or ignored for admission purposes. Applicants who elect to apply for admission under this law and who are admitted, as students may not receive any course credit for courses undertaken ten or more

years prior to enrollment. The Office of Undergraduate Admissions may be contacted for further information regarding academic fresh start. **Academic fresh start can only be applied for and granted prior to initial enrollment.**

Texas A&M University-Commerce offers a second chance for students who graduated from high school and chose to attend a four-year institution, but did not perform as well as they desired. Applicants wanting a second chance may be admitted to the university based on the freshmen criteria under the Second Chance program. All students are required to meet the university's GPA requirements in order to remain in good standing with the university.

TEXAS A&M UNIVERSITY-COMMERCE ADMISSION PROCESS

The application process varies slightly depending on a student's entry status. For example, the procedure for a student with no previous college credit is different from the procedure for a transfer student. However, **all new students:**

- must submit evidence of a level of competence in reading, writing and mathematics that will not impede their success in University Studies courses. Basic skills for college admittance can be found here: [Basic Skills Policy \(PDF\)](#); and
- are required to complete [Texas Success Initiative \(TSI\)](#) requirements and Texas A&M University-Commerce testing requirements or be exempt from assessment according to the [exemptions](#) prior to enrolling in college level courses. Students without assessment scores because of exemptions that are not test or grade based must take a placement test to determine entry level in Math and English courses.
 - You may submit scores from the THEA (Texas Higher Education Assessment), COMPASS, or ASSET to satisfy the assessment requirement. Students are responsible for providing [proof of exemption](#) and *will be considered assessment required until documentation is provided of state exemption.*

There are three pathways for being admitted to Texas A&M University-Commerce:

1. Students with little to no college credit and/or work experience
2. Students with some college credit and/or work or military experience
3. Students with an earned associate's degree

Students with Little to No College Credit and/or Work Experience

Applying to TAMU-C is easy. Our admissions counselors are available to help guide you through the application process and answer your questions. We understand that every student

is unique. TAMU-C's admissions staff can handle any situation and help make the application process flow smoothly.

State law requires first-time freshmen to either:

1. Successfully complete the curriculum requirements for the Texas Recommended or Distinguished Achievement high school program or its equivalent; or
2. Earn a combined SAT score (Math and Critical Reading scores only) of 950 or better prior to March 16 or earn a composite ACT score of 21 or higher (Math, Social Studies and English scores combined). Or, Earn a combined SAT score (Math and Critical Reading scores only) of 1060 or better or earn a composite ACT score of 21 or higher (Math, Social Studies and English scores combined) after to March 2016.

Students who have fewer than 12 college credit hours should submit a high school (or equivalent) transcript and transcripts from each college or university attended.

Students with Some College Credit and/or Work or Military Experience

Texas A&M University-Commerce is committed to making the transfer process as smooth as possible. To meet automatic admission requirements as a transfer student, you must have at least 12 transferable hours (excluding developmental coursework) and a 2.0 grade point average (GPA) or higher on all transferable coursework.

Students who do not meet the transfer student admissions criteria, are encouraged to continue taking courses at their current school or attend a community college until they have the minimum transfer hour and GPA requirements.

If you are considering dual enrollment with Texas A&M University-Commerce and another college or university and will be a financial aid recipient, please inform the Financial Aid Office and complete a consortium agreement.

Students with an Earned Associate's Degree

Texas A&M University-Commerce has transfer articulation agreements with a number of Texas colleges for associate degrees earned. If you already have earned an associate's degree that incorporates general education requirements similar to TAMU-C's requirements, you will receive credit for the University's lower division general core education requirements. Core Complete Status will be granted to students with an official transcript from a Texas state-funded college or university stating that the core was completed at that school.

Associate's degrees earned from colleges without transfer articulation agreements with TAMU-C, not designated as core complete, or not awarded in the state of Texas will be evaluated on a course-by-course basis. All students will need to complete requirements for general core education as mandated by the state of Texas and Texas A&M University-Commerce.

Additional Requirements

Entrance to the BAAS in Organizational Leaders degree program will also be contingent upon students' demonstration of college readiness per the state of Texas' new Texas Success Initiative (TSI) assessment. Students who are unable to demonstrate college readiness will be provided with academic advising to assist them in becoming college ready. Students who are eligible for a TSI waiver, chiefly active duty and retired military, will still be required to take the TSI assessment for academic advisement purposes only. 
Steps in the Admission Process for All Students



To get you started on your educational journey with Texas A&M University-Commerce, please complete and submit the online [ApplyTexas Application \(https://www.applytexas.org/adappc/gen/c_start.WBX\)](https://www.applytexas.org/adappc/gen/c_start.WBX) and list Texas A&M University-Commerce as your school of choice. A non-refundable \$60 enrollment fee will be charged to your account upon enrollment in your first semester at TAMU-C.

1a. If you do not already have an account with ApplyTexas, please create one. You will be asked to enter information to establish your free *myApplyTexas* profile.

1b. If you already have an account with ApplyTexas, this would be a good time to verify that your profile is up-to-date and has your current information.

A transcript is considered official only if received directly from the sending institution or, if hand delivered, the transcript must be in a sealed registrar's envelope. Complete the [Free Application for Federal Student Aid](#) (FAFSA) and designate TAMU-C as the college to receive your FAFSA information. **TAMU-C's school code is 003565.**

Two survey courses in American history.

Government/Political Science (6 semester hours)

Two American government/political science courses that include a study of both the Texas and United States Constitution.

Texas common course numbers: GOVT 2301 and GOVT 2302 (sequence)

Or GOVT 2305 and GOVT 2306 (sequence)

Social and Behavioral Science (3 semester hours)

One course in introductory psychology, sociology, logic, anthropology, or a survey of the social sciences dealing only with sociology and economics.

Texas common course numbers: PSYC 2301 or SOC 1301

Creative Arts (3 semester hours)

One course from music history, music literature, art history, or an introductory or survey course in theatre, or music or art or theatre appreciation. Courses in art, music, or theatre fundamentals, theory, or methods, and applied music will not substitute.

Maximizing Your Transferable Credits and Using Your Experience

In addition to taking online courses, there are several opportunities for students to demonstrate prior learning and earn college credit. Students can receive credit for military service (ACE), work experience, professional training, licenses, certifications, and by exam through the College Level Exam Program[®] (CLEP), for up to 48 semester credit hours toward their professional development electives, as well as possibly up to 42 semester credit hours of the general education/core curriculum.

- Students who have **military training and/or coursework from professional training schools** should consider contracting with Excelsior College's OneTranscript[®] service to have prior learning and courses transcribed into one consolidated transcript document. Please allow 4-6 weeks for Excelsior College to prepare a personal copy of your transcript after you submit the application and all your official documents. - Students who have **work experience/prior learning, professional training, and/or licenses** may want to consider creating their prior-learning portfolios to earn college credit for what they already know and have learned. Charter Oak State College offers prior-learning portfolios assessments for college credit. - Students may earn credit by exam in select subject areas. The College-Level Examination Program[®] or CLEP provides students of any age with the opportunity to demonstrate college-level achievement through a program of exams in undergraduate college courses. By receiving a satisfactory score, students can earn from 3 to 12 college credits toward a college degree for each CLEP exam taken, depending on the exam subject and the policy of the college or university. Students wanting to take advantage of the opportunity to earn credit by exam can do so through the Texas A&M University-Commerce testing center or through UExcel[®] at a Pearson VUE location.

Students in the BAAS in Organizational Leadership degree program develop practical workplace competencies that meet current and future challenges through applied coursework that utilizes personalized academic mentoring and instruction. Mastery areas are integrated into the following three parts of the degree:

1. General Education/Core Curriculum (42 semester credit hours) where students have the opportunity to demonstrate mastery of general education competencies without sitting through introductory courses.
2. Professional Development Electives (48 semester credit hours) where students can demonstrate competency in a variety of related fields and apply credit earned for work and military learning experiences.
3. Upper Division Applied Coursework (30 semester credit hours) which builds on and applies work-related skills in several mastery areas.

PLEASE NOTE: Students in the BAAS in Organizational Leadership degree program are required to complete an online orientation. However, they are not required to attend the university's on-campus orientation. The online orientation is designed to model the coursework competency modules to give students an example of how their coursework competencies will function. The online orientation is broken down into three competency modules. Students are required to pass each competency module with 100%, as well as accepting the Student Conduct Policy.



Tuition Guide for the Bachelor of Applied Arts & Sciences in Organizational Leadership

General Education

The general education curriculum will be delivered online and will be self-paced. Students will pay a flat rate per term, which includes textbooks provided online. Each term is seven weeks and there will be approximately six terms in the academic year. Students will register for courses, but will progress through competency-based modules and assessments. No course will be transcribed until the student has completed all competency modules and/or assessments with an 80% mastery rate.

Texas Residents pay a tuition rate of \$750 for each term. Non-Residents pay a tuition rate of \$2,500 for each term. This rate includes course materials required for competencies delivered through the online learning system. Students who wish to purchase printed versions of textbooks and required course materials will need to do so at an additional cost.

Professional Development Electives

The professional development electives will be delivered online through the university's learning management system. Texas Residents pay a tuition rate of \$750 for each term. Non-Residents pay a tuition rate of \$2,500 for each term. Students may need to purchase course materials and/or textbooks and/or access to labs as required for each course. Please note that many students may be able to satisfy up to 48 hours through transfer credit.

Upper-Level Applied Major Courses

The upper-level applied major courses will be delivered online through the university's learning management system. Texas Residents pay a tuition rate of \$750 for each term. Non-Residents pay a tuition rate of \$2,500 for each term. Cost for textbooks is not included. Students will need to purchase course materials and/or textbooks and/or access to labs as required for each course.

Please note: Costs for contracting with Excelsior OneTranscript, UExcel[®], CLEPs, CAEL's, and Charter Oak State College learning portfolios are not included in the per term tuition rate and are the responsibility of the student.
