EMERGENCY BOOKCREDIT AND PROMISSORY NOTE

This note represents emergency bookcredits charged to the account of the maker below for the **Spring 2023** semester at Texas A&M University-Commerce. I promise to pay to Texas A&M University-Commerce the principal amount of _____ dollars without grace, on or before **March 10, 2023**.

A minimum interest charge of \$5 will be assessed when your bookcredit is activated. I agree to waive demand, notice and protest, and agree to all extensions and partial payments, before or after maturity, without prejudice to the holder. If this bookcredit is not paid at maturity and is placed in the hands of a collection agency, or if it is collected through resort to a bankrupt, a probate, or any other court, whether before or after maturity, then additional late charges and collection fees on the principal and interest may be added for collection.

In case of non-payment, Texas A&M University-Commerce has the right to hold all grades, credits, transcripts, diplomas and other benefits until full payment is made. I understand this short-term institutional loan is subject to referral for collection and may be reported to national credit bureaus as delinquent when placed with an outside collection agency. I understand that I may not be eligible for future short-term loans if this loan is not repaid in full by the due date. A late fee of **\$25.00** will be assessed if this loan is not paid in full ON OR BEFORE the due date.

I understand and agree that the principal amount of this loan may be adjusted as needed to reflect the actual amount of charges through the University online bookstore; however, the principal amount cannot exceed the amount of credit originally requested. The principal amount will include the purchase price of books and supplies plus applicable shipping charges. I understand and agree that Texas A&M University-Commerce may deduct principal, and fees (including late fees or collection charges) from financial aid disbursements made to me during the **Spring 2023** semester or for any subsequent terms in which I receive financial aid through Texas A&M University-Commerce.
